By executing this Agreement, the Undersigned agrees that Clean Run shall have the non-exclusive right to use, distribute, include and copy the Photograph(s) in connection with the Magazine and in any future revisions, derivations, editions, or electronic versions thereof, throughout the world and in all languages. It is understood, however, that the right to publish the Photograph(s) shall be exclusive for 120 days from the publication of the Magazine (the "Initial Publication Period"). After the Initial Publication Period, the Undersigned shall have an unrestricted right to republish the Photograph(s) or authorize others to republish the Photograph(s).

The Photograph(s) shall be accompanied on publication in Clean Run by a credit line as follows:
